- 7. REPORTS OF MUNICIPAL OFFICERS AND COMMITTEES
- a) Administrator Boston Variance

The Administrator presented Council with a report regarding the Consent Application for Terrance and Jennifer Boston previously approved through the Committee of Adjustment. She noted that permission had been received from the Ministry of Municipal Affairs & Housing to pass a resolution rather than proceed with the lengthy process of an Official Plan amendment.

# b) Administrator – Garbage Collection Quotations

Council briefly discussed the various quotations brought forward for the collection of garbage in the Prince Lake area during the summer months. Council discussed the potential costs, the timing and the possibility of providing the service with municipal employees.

# c) Administrator - Preliminary Budget

The Administrator presented Council with a preliminary budget for 2010 for review and suggestions. Mr. Ervin and Mr. Mousseau were also present to answer questions regarding their respective departments. The following items were discussed by Council:

#### Capital Expenditures

Council discussed the estimated capital expenditures for the municipality as a whole. The Roads Superintendent explained the plans for resurfacing Walls and Deans Roads and milling Hill Road, as well as roads equipment.

The Fire Chief explained the estimates for capital equipment for the Fire department, including a fire pumper, communications and fire suppression equipment. Council discussed the potential need for portable radios and the possibility of a 4x4 truck to be purchased in the years ahead.

The Administrator noted the final share of the Infrastructure Stimulus Fund project for the Community Centre, and an allotment for a possible Ontario Trillium Grant project for parks equipment. Council also discussed the purchase of a generator and the possibility of maintenance items for the hall, which would fall under the ISF project.

#### General Government

Council discussed the estimated costs for property assessment and solicitor fees, as well as the purchase of computer equipment under the Office Supply section.

# Fire Department

Questions were asked regarding the estimated costs of vehicle repairs and apparatus/equipment repair. Council also discussed the inclusion of emergency spill kits and emergency prevention costs, as well as training, fire station and fire hydrant allotments. Council also discussed the growth of the fire department and the possible purchase of uniforms by the Firefighters' Association.

# Roads Department

Council discussed the estimated costs of the roads vehicles, safety devices and garbage collection. Council also discussed preventative measures such as emergency spill kits.

### Social/Family

The Administrator noted that the DSSAB levy was lower than previous years due to the uploading of costs to the Province.

### Recreation/Culture

Council discussed the summer day camp program as well as the funding needs for Library and Museum Boards.

Council also discussed paying off the last of the fire debenture, and the inclusion of money into reserves.

### Revenue

Council discussed the reduction in the Ontario Municipal Partnership Fund grant and the Infrastructure Stimulus Fund grant.

#### **Taxation**

Council then discussed the tax rate and various options for the tax ratios. Council agreed to proceed with the Administrator's suggestion regarding the alternative tax ratios.

The Administrator then noted that she would include the above tax ratios into the preparation for the final budget and would have the document, along with associated by-laws, ready for the next Council meeting.
