- a) Road Superintendent Road Department Update

The Road Superintendent was absent, due to an illness.

b) Fire Chief - Fire Department Update

The Fire Chief updated Council with regards to the fire department, particularly budgetary items. Council discussed the new fire pumper and repairs done to department vehicles, as well as the status of other purchases outlined in the capital budget. The Fire Chief noted that he was looking into options to buy new bunker gear in the future, as the current gear was becoming increasingly difficult to recertify for safety.

The Fire Chief then updated Council regarding training, as well as the successful application of this training to recent fire calls. Council thanked the Fire Chief for the good work of the volunteers, and asked him to consider a list of volunteers to bring supplies to fire calls if needed.

c) Administrator - Budget Update

The Administrator presented an update for the budget from January to July 2010. Council discussed several items, included the work completed in the cemetery, the funding requirement for the Sault Area Hospital, and the application to Trillium for parks equipment. Council also discussed the state of the Gros Cap cemetery; Council Williamson noted that she would make an official complaint on behalf of Council.
