- 8. REPORTS OF MUNICIPAL OFFICERS AND COMMITTEES
- a) Administrator Fire Vehicle

The Administrator and Fire Chief Mousseau presented Council with information regarding an opportunity to purchase a fire pumper previously used by the Sault Ste. Marie Fire Services, available through Safetek Emergency Vehicles for \$45,000.

Chief Mousseau described the fire vehicle, with consideration to its years of service and its general condition. Council members discussed what would be included with the vehicle and the timing of the purchase. Council then debated the merits of purchasing this used vehicle versus putting funds into a reserve for a future purchase of a new vehicle, as well as possible funding grants that could be used to purchase a fire pumper vehicle.

Council then voted on the purchase of the used fire pumper, in principle; Councilor Lamming asked for a recorded vote.
