- 8. REPORTS OF MUNICIPAL OFFICERS AND COMMITTEES
- a) Administrator Winter Emergency Response Policy

The Administrator presented Council with a Modified Fire Response Policy dealing with areas within the municipality that are more difficult to reach using traditional fire response techniques. The Administrator explained that this policy was written in tandem with the Fire Chief, solicitor, advisor from the Office of the Fire Marshall and insurance advisor.

Council discussed the suggested policy, particularly the elements of equipment and training. Chief Mousseau noted that there would be extensive training combined with prevention campaigns specific to the Prince Lake and hamlet areas. He also noted that operating guidelines would need to be created based on this training.
