a) Administrator - Presentation of reports regarding emergency response

The Administrator read the written reports provided by the solicitor, insurance advisor and advisor from the office of the Fire Marshall.

Council then discussed the advice provided in the professional reports, noting that fire fighter safety was of paramount concern. Questions were raised regarding the possible storage and access of equipment at Prince Lake as well how water could be collected from the lake. It was also suggested that a potential policy should set out a maximum number of responders and that fire response would be limited to external suppression.

Chief Mousseau responded to questions posed by Council members, noting equipment and training considerations that would be needed with a winter response policy. Council then asked the Administrator and the Fire Chief to draft a policy for consideration, with legal and legislative advice, that would clearly set out the response and the limits of accessibility so both residents and firefighters would be prepared in the event of an emergency.
