- 8. REPORTS OF MUNICIPAL OFFICERS AND COMMITTEES
- a) Administrator Official Plan Amendments

Council discussed the proposed amendments to the draft Official Plan brought forward on behalf of the Planning Consultant.

Council members discussed their concern with the amendment requiring Batchewana First Nation be consulted where archeological studies are required. Councilor Lamming also raised a concern with a section not proposed for amendment, that of section D2 regarding equipment allowed for home based businesses.

Council discussed their concerns, and asked the Administrator to consult the Planning Consultant for more information.

"Resolved that the Council of the Township of Prince approve the following amendments to the draft Official Plan;

- 1 The section C 7.2 (3) be amended changing the maximum building area for recreational dwellings in the Prince Lake and Jackson Island area from  $65 \text{ m}^2$  to  $95 \text{ m}^2$ .
- 2 That Section A 3.1 be reworded moving "Section 34 Comprehensive Zoning By-law" from the Ministry's approval authority to the Townships.
- 3 That the word City's in the second paragraph of section A 3.2 be changed to Municipality's.
- 4 That the following paragraph be added prior to the last paragraph of section B 5.2;

"That the archeologist preparing an archeological study consult with the Batchewana First Nation prior to commencing the study and share the results of said study with Batchewana First Nation once completed." Section taken out per council instruction

- 5 That section C10.1 (5) be amended to add a school bus to the list of equipment that could be included as part of a home based business or occupation.
- 6 That the word "shall" be replaced with the word "may" in the first line of section D 6.2

# b) Administrator – Forest Fire Management Agreement

The Administrator presented Council with a proposed Forest Fire Management Agreement brought forward by the Ministry of Natural Resources. She noted that Council could decide the Fire Department to take over two additional areas for forest fire protection, or leave the agreement as is.

Chief Mousseau spoke to Council regarding the agreement, noting his concern for the unofficial "300 feet" off municipal roads for the municipal protection area. He also noted he would like some portable equipment available from MNR in case a forest fire does occur in those areas.

The Administrator noted that the agreement was only in respect to forest or brush fires, not in relation to house or building fires.

Councilor Williamson suggested a meeting be scheduled with the representatives of the Ministry to gather more information. The Administrator advised that she would try to set this up quickly, as the current forest fire management agreement expires  $April\ 1^{st}$ .

# c) Administrator - Burning By-Law

The Administrator then presented Council with a sample open air burning by-law and the elements that could be used for the municipality. These include simplified writing and which items could not be burned.

Council discussed the issue of burning leaves, with the concern for safe burning versus the ability to burn yard waste as needed. Councilor Yanni suggested burning leaves could be permitted at certain times of the year; Council agreed. Chief Mousseau also noted that there would need to be clear instructions regarding where and how to burn, with punishments if necessary.
