#### 10. CORRESPONDENCE

a) Ministry of Municipal Affairs and Housing – Official Plan modifications

Mr. Wierzbicki was present to discuss the draft modifications for the Official Plan provided by the Ministry of Municipal Affairs and Housing. He noted that many of the amendments were straightforward and simply reworded for clarity. However, the issue of severances and subdivision restrictions were not favourable to the goals of the municipality.

Council discussed the draft modifications, in particular the restrictions for severances outside the Hamlet area. Mr. Wierzbicki noted that the modifications were consistent with the Provincial Policy Statement, but that it did not work well in a rural Northern community such as Prince. As such, he will develop an argument to provide to the Ministry, in favour of changing the restrictions for severances and subdivisions.
